Major Conference on NAFTA: Globalization's Blueprint

Civil Society leaders from Mexico, Canada and the U.S. to attend

MINNEAPOLIS — As the three participating countries await the final provisions of the North American Free Trade Agreement (NAFTA) to go into effect in 2008, academic experts and farm, labor and environmental leaders will gather in Minneapolis in October to evaluate the controversial trade agreement and develop a new fair trade agenda.
