IATP AND PARTNERS IN THE U.S. AND EU PUBLISHED A REPORT ON THE SCALE OF POLLUTION FROM THE WORLD'S BIGGEST MEAT AND DAIRY COMPANIES, WHICH HAS BEEN CITED IN MORE THAN 80 ARTICLES BY GLOBAL MEDIA OUTLETS REACHING OVER 600 MILLION READERS WORLDWIDE. IN 2025, IATP PUBLISHED ANALYSIS AND REPORTING ON HOW THE USDA CUTS TO CONSERVATION PROGRAMS AND STAFF HAVE MADE IT HARDER FOR FARMERS TO ACCESS IMPORTANT PROGRAMS THAT HELP PROTECT THE CLIMATE. WE ALSO PUBLISHED ANALYSIS ILLUSTRATING THE SCALE OF HISTORIC AND CURRENT UNMET DEMAND FOR CONSERVATION PROGRAMS AMONG FARMERS.

IN 2025 WE CLOSELY MONITORED NEGOTIATIONS OF THE U.S.-MEXICO-CANADA AGREEMENT (USMCA), VOICING THE CHANGES NEEDED FOR A MORE JUST AND TRANSPARENT TRADE POLICY. WE SUBMITTED WRITTEN TESTIMONY IN SUPPORT OF TRANSPARENCY IN FOOD LABELING, CHALLENGED RISING CORPORATE CONCENTRATION, AND CALLED FOR INTELLECTUAL PROPERTY RESTRICTIONS TO BE RELAXED IN FAVOR OF FARMER-CONTROLLED SEED SYSTEMS. WE ENGAGED IN DISCUSSIONS AROUND LAND USE AND DEFORESTATION IN AGRICULTURAL COMMODITY SUPPLY CHAINS, WORKING CLOSELY WITH GLOBAL PARTNERS, INCLUDING THE CONTRIBUTION OF A CHAPTER TO THE 2025 LAND GAP REPORT THAT ANALYZED THE ROLE THAT GLOBAL TRADE PLAYS IN EXACERBATING CLIMATE CHANGE AND BIODIVERSITY LOSS. IATP AND OTHER EXPERTS ACROSS HEMISPHERES CONTINUED WORK ON THE AGREEMENT ON AGRICULTURE RE-IMAGINED, A THREE-YEAR INITIATIVE TO RETHINK THE WORLD TRADE ORGANIZATION'S AGREEMENT ON AGRICULTURE, THE GLOBAL TREATY FOR AGRICULTURE TRADE THAT HAS BEEN IN EFFECT SINCE 1995. THIS PROJECT ENDS IN MAY 2026. WE ALSO SERVED AS A TRUSTED RESOURCE FOR INFORMATION AMID THE STORM OF THIS U.S. ADMINISTRATION'S CHAOTIC TARIFF POLICY, HOSTING WEBINARS AND PUBLISHING ARTICLES ON HOW TARIFFS WORK AND THEIR IMPACTS ON OUR FOOD SYSTEM.
